We, our international Academy of public development (International public development Academy), tries to bother you no more often than once a year.

04. 2009: To the European Commission, Directorate-General for Education and Culture, Deputy Head of Unit Roger O'keeffe - our congratulations with a remarkable program of the year-2009 and the offer to work together. In this proposal there was no answer, but we have received a full package addresses performers and workshops on this topic. With great interest got acquainted with your work, and identified many weaknesses. Noted the lack of textbooks for the teaching of creation - and we have already published a textbook «NOVISTICS», IPDA, 2009

06.2010. For a Consultative group on working out Reforms of economic management. We proposed to improve the system of education and the system of product certification of quality and ecological compatibility - this will allow the introduction of market principles in innovative development.

06.2011. In several of the address was sent to the following text:

...As it is known, by the decision of Euro Parliament by the initiative of Euro Commission (**DECISION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL concerning the European Year of Creativity and Innovation (2009)**) the year 2009 was solemnly announced in Europe as a year of creativeness and innovations and then all Europe was announced creative. Namely in this 2009, we succeeded to publish a special textbook NOVISTICS – to the best of our knowledge, it is the first one on this topic in such a complex content (the English version of the 1st Part was attached).

If we are not wrong, Europe (to be more exact, Euro Commission, Euro Parliament) is much more interested in development of this line than Russia. And no wonder: in Europe are many enterprises producing fine goods and obviously interested in exposing the quality of their goods at the expense of their renovation with the help of innovative means. In Europe will sought the ways of lowering the harm due to the auto transport And we are ready to share (to show) our instruments of calculation of the quality of goods and services, of social effect and damage, as well as to share the whole theory and practice for estimating the total (comprehensive) social efficiency of innovations including the social factors, moral depreciation in terms of novelty and efficiency. We together with your experts can also develop a proper textbook on the innovates taking into account the European conditions of production and public life.

The materials we know about from the Internet show that many issues are developed by us better than in Europe, which can be related to that we are engaged with it very long – since 1973-75s. Let's repeat: this finding is made on the basis of the information published in the Internet and supposing that your scientists do not try to conceal their achievements.

Note: we have taken into account the detailed analytical results by the Institute of Seville (The Institute for Prospective Technological Studies - IPTS) and the results of some workshops (for example, the conference 7- 9. 10. 2009, Linz). Unfortunately, for the time elapsed since then we could not see any progress in this matter.

We ask you to pass our suggestions on our readiness to closely cooperate to some of your institutes or some interested persons in Euro Commission, for instance, c Mr. Roger O'Keeffe.

Of course, we know that the states of EU have a great portion of independence including this matter. But we believe that BEFORE addressing each of them it would be correct to discuss the matter with the Center, which have prepared such a highly profound Decision and which obviously waits for the appropriate results of its implementation. OR to make it in parallel? We are sure that the proposed (by us) refinement of methodical apparatus will enable to do it much sooner and more efficiently. If there would be a need, we (1 – 3 persons) are ready to carry a cycle of classes to prepare and advance the teachers by their wish. The venue and some conditions for that should be discussed.

We are waiting for your suggestions on the cooperation with great interest.

In this letter there was no answer.

As we all know, the economic and socio-political situation in Europe is not improving. And it means, that the chosen system of power in need of radical improvement, by not applying the revolutionary measures, which, as is known, are never without significant public losses. Radical improvement in our opinion, should include the replacement of a purely economic priorities for the socio-economic, when the social acquisition could compensate for some of the economic failures and delivered to the population is quite significant satisfaction. For demonstration of the social progress beyond GDP we offer for our government introduce an indicator of social development and to make an introduction a number of other projects. Part of them is designed by our Academy. Europe can do it earlier Russia.

But first she must complete the most ambitious project of perfection of Europe, proposed by the European Parliament in 2009. Including full reform of the system of education.

...ABOUT THE PROJECT «NOVATIVE EDUCATION» - for teachers, scientists and experts

«This book is prepared on the basis of the conclusion and recommendations of the Ministry of Education and Science of the Russian Federation. It is prepared proceeding from the necessity precondition to begin introduction in practice of teaching at compulsory schools, and then at high schools, of the theory of creativity and practice of the innovative activity (we consider more precisely – novative, i.e. not only at the stage of realization of creative projects). Simultaneously it is necessary to essentially lower the volume of compulsory injection in the pupils' heads, without dependence from their preferences, some dogmatic material in all – as if immemorial and for ever, but thus to teach it in a dialectic form, with an explanation of how and in what conditions it was created, opened, or invented, what difficulties were overcome, with an explanation of indispensable exceptions of the conventional laws and with obligatory examples of their application. But for the pupils having sharp preferences of some subjects, we, on the contrary, consider the necessity of creation for them the most favorable, conditions for studying of these disciplines. It is possible to consider, that this time opens a new era in pedagogy, corresponding to the new Space age: one should not so much trust and worship, but, the main thing, – CREATE AND IMPROVE, to invent new and useful things, to become an architect and a smith of the life».

This book provides a deep understanding of the essence of innovation in the human community. Including social innovation. Their value of the human community is only beginning to understand.

I suggest you consider this book, do the translation in several languages and dissemination from the European Commission to the European countries.

You should pay attention to the fact that, against this book will always be teachers, traditionally configured on the infusion of the heads of the disciples of the maximum volume of knowledge in the subjects,

even if they never come in handy. Psychologically overcome this attitude it will be extremely difficult. So the European Commission must decide the question of the value of the new approach for the further development of the company, asking questions teachers *only when* it will be solved a question about the methods of teaching and selection of the most valuable material in the revision of textbooks. But not at the stage of solution of the question: to do this reform or not.
